Payhembury Parish Council

Draft Minutes of a Payhembury Parish Council Committee meeting held on Wednesday 13th July 2016 at 7.30pm in the Parish Hall.

- 1. Apologies: Cllrs Leach, Eaton, Diviani, Skinner & PC Anning.
- 2. The minutes of the previous meeting were agreed as correct and signed.
- 3. Public Session: It was suggested that Adrian Le Page, as our Road Warden be added to Agenda for any road reports he is able to give.
- 4. Police Report: the Clerk gave the Police report. 2 crimes have been reported since the last meeting. 1 being a burglary into commercial premises & the second being a dog incident with a delivery driver being bitten.
- 5. County Council Report: Cllr Diviani had previously circulated a report.
- 6. District Council Report: None provided.
- 7. Broadband update: Cllr Williams & Graham Smith reported that the bid for funds from the EU Regional Development Bid with the Blackdown Hills Network had failed. It is anticipated the cabinet on Colliton Cross will be activated soon (July). Distance from the box impacts on the success of superfast. Not all Parishioners can apply for it there doesn't appear to be a clear pattern. Agreed to wait & see what happens after switch on. Discussion around a Parish Project to lay the fibre from the box into the village to be discussed at a further meeting if no real improvement seen.

Clerk to re-circulate the communication from EE regarding Mobile broadband.

- 8. Parish Clerk: 2 expressions of interest have been received for the Parish Clerk role. An interview to be arranged with both. Clerk to pull together a job description. Clerk to speak to Feniton PC regarding the Clerk's employment status.

Invoices received: Reminder from DCC for £2729.07 (contribution from EDDC for pavement).

Clerk reported the Year End Accounts had been submitted to the External Auditor.

10. Uggaton Cross: The Surveyor has assessed the site. The badgers are active and have been under the road in the past, but are not currently. The quote from DCC for £15,000 was discussed. This included the installation of the badger proof fence and the road repair.

Cllr Disney offered to obtain a second quote from a fencing contractor. If more affordable, it was agreed for the Parish Council to cover the cost of the fence and ask DCC to cover the road repair costs.

- 11. Neighbourhood Plan: EDDC has given £2,000 to kick start the plan. Iestyn Johns is working with possible Consultants who will then apply for further funding, to formulate the Questionnaire & plan. A Consultant will be selected by the working party.
- 12. Street Light: the Committee visited the potential site for a new street light. Clerk to ask the School if they would agree for the light to be positioned within the barrier on the pavement outside the Willow School gate. Clerk to confirm positioning with Highways.
- 13. Parish Issues: Parking in village: approach the Parish Hall committee about adding a parking sign on the Parish Hall gate. Possibly put a Parking sign on the shop wall, pointing into the car park. Clerk to approach Highways for advice & costs for yellow lines on the road outside the shop & school. Add to open projects. Route Maps: Nothing to

report. Mirrors at Colestocks Farm: review once the developments are completed, however it was felt the entrance had been widened to avoid any such issues. War Memorial: Clerk to chase Torquill for his inspection report. Add to open projects.

Hedge Cutting: a Parishioner had raised a query over hedge trimming. All reminded of the rules that hedges can only be trimmed before the end of August if proving a danger to road users.

Playing Field Gate: the gate is not easy for use for all, particularly pushchairs & wheelchair users. Clerk to ask EDDC if \$106 monies could be used to replace it.
